Judging Criteria:

The judging committee, consisting of credit union professionals will score each applicant on the following criteria:

- 1. Verification of Attendance
- 2. Letters of Recommendation
- 3. Career goals
- 4. Professional presentation

Application Deadline:

Applications must be postmarked by Sunday, March 31, 2024. Applications should be sent to the following address:

Scholarships:

Northern Hills Federal Credit Union will award a \$1000 scholarship to a non-traditional, post-secondary student that exemplifies the credit union philosophy of "people helping people" through volunteering, community service, and leadership. The scholarships will be awarded for the 2024-2025 school year. The proceeds will be mailed directly to the financial aid office at the school shown on the application upon receiving verification of enrollment from the scholarship recipient.

Eligibility Requirements:

- ☐ The applicant <u>must</u> be a member in good standing of Northern Hills Federal Credit Union.
- At least three years have passed from the applicant's graduation date from high school or a qualifying GED program.
- The applicant must not already hold a bachelor's degree.
- ☐ The applicant must be attending or plan to attend an accredited college, university, or vocational/technical school within the next calendar year.

Application Requirements:

- □ A completed copy of the application form.
- An official copy of cumulative college transcripts or a letter of acceptance from the University that the applicant plans to attend.
- One personal and one professional written letter of recommendation.
- □ A two-part essay describing
 - Your career goals
 - How your community/work experiences have exemplified the credit union philosophy of "people helping people."
 - Steps you will take to ensure your success

Essay should be, typed, double-spaced on plain white paper.

Section I: Verification of Attendance

1. Attach an official copy of cumulative college transcripts OR a letter of acceptance from the University you plan to attend.

Section II: Letters of Recommendation (10 points)

- 1. Attach one personal written letter of recommendation. This could be from a friend, family member, co-worker or community person.
- 2. Attach one professional written letter of recommendation. This could be from an employer, former teacher, coworker, or supervisor.

Section III: Career Goals (80 points)

- 1. Essay should be typed, doubled-spaced on a separate sheet of plain white paper and attached to the application.
- 2. Essay should respond to the following:
 - a. Describe your career goals and discuss your decision to take this step at this time. Name the institution you plan to attend and on what you based this decision 200 to 300 words (30 points)
 - b. Describe how your community/work experiences have exemplified the credit union philosophy of "people helping people" 120 to 150 words (20 points)
 - c. Describe what steps you will take to ensure your success 120 to 150 words (30 points)

Section IV: Professional Presentation (clarity, completeness, writing) (10 points)
